- Rosettes will be awarded to all dogs qualifying in each stake.
- BITCHES IN SEASON WILL NOT BE ALLOWED ON TEST GROUNDS.
- Refund of entry fee, minus \$5.00 will be made for bitches in season and dogs unable to run due to illness or injury, with written certification by licensed veterinarian. Must scratch prior to start of judging each day.

Directions to test site headquarters at Webshire

From Milwaukee: Take Hwy. 41 to Hwy. 76. Go North on 76 to County Rd. II (that's the "letters" II, not the "roman numeral" II). Turn left (west) on II and follow approximately 8 miles to Winchester. Go through Winchester and over Hwy 45. Continue 1 mile to County Rd M. Turn left (south) onto CR-M and follow 1 mile to Grandview Rd; there will be a fork in the road. Veer to the left and turn left. Go 1/2 mile to Webshire Kennels –watch for sign and driveway on left. Address is 5694 Grandview Rd, Larsen, WI 54947.

From Stevens Point: Take Hwy. 10 East to County Rd. II exit. Turn right. Go 1 mile to County Rd. M. Turn left onto M and follow 1 mile to Grandview Rd. Veer to the left and turn left. Go 1/2 mile to Webshire Kennels – watch for sign and driveway on left. Address is 5694 Grandview Rd, Larsen, WI 54947.

From Green Bay: Follow 41 south to Hwy 10 west. Follow Hwy 10 West approx 8 miles to Hwy 45. Exit Hwy 45 south (left lane exit) and follow to CR-II and turn right. Continue following directions as if coming from Stevens Point.

Note: Directions to Ridgeway will be available at test site headquarters.
